- > Male competitors <u>must</u> have groin guards.
- Female competitors may wear soft style breast guards only (AKKA approved type only). You must present these for inspection at the weigh-in.
- > Any female discovered fighting with a non approved breast protector will be immediately disqualified.
- > Novice competitors MUST wear leg/instep protectors
- Intermediate may wear shin/instep guards (optional).
- Organisers reserve the right to combine divisions if needed (competitors will be notified): heavyweight competitors please note that the superheavyweight and heavyweight divisions may be merged.
- Late competitors, or competitors withdrawing from their match without permission of the organisers, will forfeit their entry fee and the match.
- > Incorrect weight will result in disqualification, unless an opening is available in the heavier division.
- If the starting time or weigh in time is altered, competitors will be notified.
- Competitors not weighing in by the starting time will be disqualified.
- By entering this tournament the competitor hereby gives the organisers permission to take photographs of the competitor and to use those photographs in promotional material by the AKKA Inc. and VKKA Inc.
